PRODUCT DETAILS

Product name: 5%, 15%, 25% CBD Oil Full Spectrum MCT

Product category: Body care product/cosmetic item of use. Not suitable for consumption.

Cosmetic Product Safety Assessment: The cosmetic product 5%, 15%, 25% CBD Oil Full Spectrum MCT can be assessed as SAFE WITH RESTRICTION for normal and reasonably foreseeable use in accordance with the European Cosmetics Regulation (EC) No 1223/2009 (as amended) respectively. The product does not fully comply with the Regulation and its annexes as it includes a prohibited ingredient – cannabis sativa extract. The margin of safety, which takes into account all systemic toxicity endpoints, has been calculated for each of the ingredient used in this cosmetic product. All ingredients (where the NOAEL value was available) have a sufficiently large MoS (>100), which is supporting the safety of the finished product. Specific exposure consideration for the targeted consumer group (adults) has been taken into account as documented in the exposure and MoS calculation.

The product includes Cannabis sativa extract, which is found in annex II of the EC Regulation 1223/2009 and as such is prohibited for use in cosmetics sold on the EU market. Based on the fact that many similar products are on the market and are sold as cosmetics, foods or food supplements (*European Monitoring Centre for Drugs and Drug Addiction (EMCDDA) (2020), Low-THC cannabis products in Europe.*) and based on the evaluation of available data on the safety of ingredients, the product is expected to be well tolerated.

PARAMETERS

Pure Production AG initiates the creation of a CPNP-notice through a third party via the dealer function on the CPNP-portal on behalf of "CC Grosshandel GmbH". The dealer "CC Grosshandel GmbH" is informed that the third party has the right to create the request in the CPNP-portal via their account.

The customer "CC Grosshandel GmbH" hereby registers and confirms that they themselves are the responsible party (RP) for their product and not Pure Production AG. The customer is thus responsible for the labeling and instructions of use. The dealer is responsible for all regulatory compliance in their country.

What is the Cosmetic Products Notification Portal?

CPNP is the free of charge online notification system created for the implementation of Regulation (EC) N° 1223/2009 of the European Parliament and of the council on cosmetic products.

Take note: a successful CPNP-notice doesn't mean that the product is marketable. This means a product which is successfully notified through CPNP does not necessarily imply that the product in question fulfills all the requirements of the Regulation (EC) N° 1223/2009 of the European

Parliament and of the council on cosmetic products. It is the dealer's responsibility to obtain market authorization as well as correct labelling and packaging.

What information needs to be entered into CPNP?

Article 13 of Regulation (EC) N° 12233/2009 lists the information that the responsible persons and, under certain circumstances, the distributors of cosmetics products shall notify through CPNP about the products the place or make available on the European market.

RESPONSIBLE PARTY (RP)

Only cosmetic products for which a legal or natural person is designated within the EU as a "responsible party" can be placed on the EU market. The Responsible Party shall ensure compliance with the obligations set out in Regulation (EC) N° 12233/2009.

Who is the Responsible Party?

- If a product is manufactured in the EU (and not subsequently exported and imported back into the EU) and marketed in the EU, but the manufacturer is established outside the EU, a Responsible Party established in the EU must be appointed.
- The distributor shall be the Responsible Party where he places a cosmetic product on the market under his name or trademark or modifies a product already placed on the market in such a way that compliance with the applicable requirements may be affected.

The translation of information to a cosmetic product already placed on the market shall not be considered as a modification of that product of such a nature that compliance with the applicable requirements of this Regulation may be affected.

REGISTRATION

In order to access CPNP, the user needs a user login, a password, an organization, a role, and a profile. This information needs to be provided to Pure and its third party partner for the registration process. The information is treated confidential and only for the CPNP registration process for the products name here on this declaration.

Two systems are needed:

- EU Login
The European Commission Authentication Service (formerly known as "ECAS") with which people can access different applications and services offered by the European Commission.
- The Sante Authorization System (SAAS)
This system provides the user with an organization, a role, and a profile for having the access rights for a specific European Commission application, in this case CPNP.
